#### **Dalene Dutton FACJJ Vice Chair**

Dalene Dutton is the Executive Director of Five Town Communities That Care, a community prevention agency with offices in Rockport, Maine. In addition to providing oversight for the agency's local operations, Ms. Dutton provides consulting and training in the Communities That Care (CTC) system, coalition development and sustainability, program implementation and evaluation, juvenile justice, and prevention science to groups across the Americas.

Ms. Dutton received her undergraduate training at McGill University and the University of Maine, Orono (BS: Secondary Science Education) and earned a graduate degree from Lesley University (MS: Ecological Teaching and Learning). She has also earned a Certificate in Non-Profit Leadership. Ms. Dutton was a fellow in the inaugural classes of the Midcoast Leadership Academy, the Governor's Academy for Teacher Leadership, and the NSTA-funded Northern New England Co-Mentoring Network for Math and Science Teaching. She received the Maine Commissioner of Education's 2007 Outstanding Alternative Educator Award and was recognized in 2009 by the Maine Alliance for the Prevention of Substance Abuse with its prevention person of the year award.

A native of Maine, Ms. Dutton and her husband raised their three children on the family farm where the couple still resides.



#### **Jaime Koppel OJJDP Senior Fellow**

Jaime Koppel is a Senior Fellow in the Office of Justice Programs, Office of Juvenile Justice and Delinquency Prevention, with responsibility for advancing and elevating work on school discipline. She is on detail from her position as a Senior Research Associate at the Research Foundation of the City University of New York. Jaime previously served as the Director of Youth and Education Justice at the Children's Defense Fund-New York (CDF-NY). Prior to her advocacy work with CDF-NY, she was Chief of Staff to the Deputy Executive Commissioner of the NYC Administration for Children's Services. Jaime is also the founder of a nonprofit organization, Bilingual Education for Central America (BECA), which



works in collaboration with underserved Honduran communities to promote cultural exchange and provide a high quality, low- to no-cost bilingual education at community-run schools. Jaime has an MPA from Columbia University's School of International and Public Affairs.



**Arlene Lee**

**Board Director, Committee on Law and Justice, The National Academies**

Arlene F. Lee, J.D., is Board Director for the Committee on Law and Justice (CLAJ) of The National Academies and manages a range of activities, including a study on the Causes and Consequences of the High Rates of Incarceration and a roundtable on crime trends. In addition, with the Institute of Medicine she co-managed a study sponsored by the Centers for Disease Control and Prevention and requested by the White House on a Public Health Research Agenda to Reduce Firearms Violence. Before joining CLAJ, she was Director of Policy at the Center for the Study of Social Policy, where she focused on helping federal and state elected officials develop research-informed policies to improve results for children and families. Previously, she was Executive Director of the Maryland Governor's Office for Children and has served as Deputy Director of the Georgetown University Center for Juvenile Justice Reform, Director of the Federal Resource Center for Children of Prisoners, and Youth Strategies Manager for the Governor's Office of Crime Control and Prevention. She is also the author of numerous articles and co-authored *The Impact of the Adoption and Safe Families Act on Children of Incarcerated Parents*. As a result of her work, she was named one of Maryland's Top 100 Women and has received three Governor's Citations. She has a B.A. in Sociology from Washington College and a J.D. from Washington College of Law, American University.



**Robert L. Listenbee, Jr.**

**OJJDP Administrator**

Robert L. Listenbee, Jr. is the Administrator of the Office of Juvenile Justice and Delinquency Prevention. He was appointed to the position by President Barack Obama in February 2013. Prior to his appointment, Mr. Listenbee was Chief of the Juvenile Unit of the Defender Association of Philadelphia for 16 years and a trial lawyer with the association for 27 years. As a member of the Juvenile Justice and Delinquency Prevention Committee of the Pennsylvania Commission on Crime and Delinquency, he advised Pennsylvania's governor on juvenile justice policy. Mr. Listenbee served as chair of the Defender Policy Group of the National Legal Aid & Defender Association and on policy committees of the National Center for Juvenile Justice.



Mr. Listenbee also served on the advisory board of the National Juvenile Defender Center and was actively involved in the MacArthur Foundation's Models for Change initiative in Pennsylvania. He served as president of the Juvenile Defenders Association of Pennsylvania and was a member of the Juvenile Indigent Defense Action Network, which works to improve access to counsel and the quality of representation for Pennsylvania's children.

Mr. Listenbee co-chaired Attorney General Eric Holder's National Task Force on Children Exposed to Violence and served as a member of OJJDP's Federal Advisory Committee on Juvenile Justice, which advises the President, Congress, and the OJJDP Administrator on juvenile justice policy.

Mr. Listenbee received his B.A. degree from Harvard University and his J.D. from the Boalt Hall School of Law at the University of California, Berkeley.



## **James Moeser**

### **FACJJ Chair**

Jim Moeser has worked in juvenile justice for almost 40 years, serving in a number of state and local leadership positions. Jim has been involved in a wide variety of community and juvenile justice system-related efforts, has provided training and consultation in Wisconsin and throughout the country in areas of Balanced and Restorative Justice (BARJ), juvenile detention alternatives, coordinating mental health and juvenile justice services, juvenile offender reentry, and victim-offender conferencing and other restorative practices. He has served on numerous local and state boards and committees and is currently Chair of the Governor's Juvenile

Justice Commission (Wisconsin's SAG). In November 2008, Jim assumed the role of Deputy Director of the Wisconsin Council on Children and Families, a multi-issue state advocacy organization promoting the safety, health, and economic stability of Wisconsin's children and families.
