**Robert L. Listenbee, Jr.**  
**OJJDP Administrator**

Robert L. Listenbee, Jr. is the Administrator of the Office of Juvenile Justice and Delinquency Prevention. He was appointed to the position by President Barack Obama in February 2013. Prior to his appointment, Mr. Listenbee was Chief of the Juvenile Unit of the Defender Association of Philadelphia for 16 years and a trial lawyer with the association for 27 years. As a member of the Juvenile Justice and Delinquency Prevention Committee of the Pennsylvania Commission on Crime and Delinquency, he advised Pennsylvania's governor on juvenile justice policy. Mr.

Listenbee served as chair of the Defender Policy Group of the National Legal Aid & Defender Association and on policy committees of the National Center for Juvenile Justice.

Mr. Listenbee also served on the advisory board of the National Juvenile Defender Center and was actively involved in the MacArthur Foundation's Models for Change initiative in Pennsylvania. He served as president of the Juvenile Defenders Association of Pennsylvania and was a member of the Juvenile Indigent Defense Action Network, which works to improve access to counsel and the quality of representation for Pennsylvania's children.

Mr. Listenbee co-chaired Attorney General Eric Holder's National Task Force on Children Exposed to Violence and served as a member of OJJDP's Federal Advisory Committee on Juvenile Justice, which advises the President, Congress, and the OJJDP Administrator on juvenile justice policy.

Mr. Listenbee received his B.A. degree from Harvard University and his J.D. from the Boalt Hall School of Law at the University of California, Berkeley.



**Dalene Dutton**  
**FACJJ Chair**

Dalene Dutton is a Communities That Care Specialist with the University of Washington's Social Development Research Group. Ms. Dutton provides consulting and training in the Communities That Care (CTC) system, coalition development and sustainability, program implementation and evaluation, juvenile justice, and prevention science to groups across the Americas.

Ms. Dutton received her undergraduate training at McGill University and the University of Maine, Orono (BS, Secondary Science Education) and earned a graduate degree from Lesley University (MS, Ecological Teaching and Learning). She has also earned a Certificate in Non-Profit Leadership. Ms. Dutton was a fellow in the inaugural classes of the Midcoast Leadership Academy, the Governor's Academy for Teacher Leadership, and the NSTA-funded Northern New England Co-Mentoring Network for Math and Science Teaching. She received the Maine Commissioner of Education's 2007 Outstanding Alternative Educator Award and was recognized in 2009 by the Maine Alliance for the Prevention of Substance Abuse with its prevention person of the year award.



**James Moeser**  
**FACJJ Vice Chair**

Jim Moeser has worked in juvenile justice for almost 40 years, serving in a number of state and local leadership positions. Jim has been involved in a wide variety of community and juvenile justice system-related efforts, has provided training and consultation in Wisconsin and throughout the country in areas of Balanced and Restorative Justice (BARJ), juvenile detention alternatives, coordinating mental health and juvenile justice services, juvenile offender reentry, and victim-offender conferencing and other restorative practices. He has served on numerous local and state boards and committees and is currently Chair of the Governor's Juvenile

Justice Commission (Wisconsin's SAG). In November 2008, Jim assumed the role of Deputy Director of the Wisconsin Council on Children and Families, a multi-issue state advocacy organization promoting the safety, health, and economic stability of Wisconsin's children and families.



**Scott Pestrige, Acting Designated Federal Official (DFO) and Senior Policy Advisor  
Office of Juvenile Justice and Delinquency Prevention  
U.S. Department of Justice**

Scott Pestrige is a Senior Policy Advisor with the Office of Juvenile Justice and Delinquency Prevention (OJJDP). In this role, he supports policy development related to areas including mentoring, police and youth engagement, and work focusing on Latino youth. Previously, he worked as a Program Manager with OJJDP's Youth Development, Prevention, and Safety Division, where he had oversight of cooperative agreements with 25 Internet Crimes against Children (ICAC) Task Forces, in addition to managing cooperative agreements with the National Center for Missing and Exploited Children and the AMBER Alert Training and Technical Assistance award with Fox Valley Technical College.

He has worked with the Department of Justice for 17 years, serving at the Drug Enforcement Administration, Office of Community Oriented Policing Services, and OJJDP. In these positions, Mr. Pestrige has worked with discretionary programs, formula and block grant programs, as well as federal interagency funding initiatives.

He began his career in the juvenile justice field as a case manager for a juvenile diversion program in Baltimore, MD. He subsequently directed an AmeriCorps program within the Maryland Department of Juvenile Services that provided supervised linkages for adjudicated youth performing court-ordered community service. He holds a master's degree from the University Of Maryland School Of Public Policy.



**John A. Tuell, Executive Director

John A. Tuell, BSW, MA, currently serves as the Executive Director for the Robert F. Kennedy National Resource Center for Juvenile Justice at Robert F. Kennedy Children's Action Corps. Prior to this appointment, Mr. Tuell served as the Co-Director of the MacArthur Foundation's *Models for Change: Systems Reform in Juvenile Justice* Initiative at Robert F. Kennedy Children's Action Corps. Mr. Tuell has also served as the President of Tuell & Associates Consultation, LLC which provided expert consultation and technical assistance in juvenile justice, child welfare and multi-system reform and quality improvement. Mr. Tuell was also an instructor to Multi-System and Information Sharing Certificate Programs at the Georgetown University's McCourt School of Public Policy.

Mr. Tuell has been an author and contributing author to numerous publications that support the work of the Dual Status Youth Initiative and Probation System Review, and related issues impacting the juvenile justice system. Prior to the initiation of the MacArthur Foundation work in 2001, Mr. Tuell served in the U.S. Department of Justice from 1997-2001, during which time he was the Deputy Director of the State Relations and Assistance Division in the Office of Juvenile Justice and Delinquency Prevention (OJJDP). Mr. Tuell also worked in the Fairfax County, Virginia Juvenile and Domestic Relations District Court in probation and residential group care for delinquent offenders.

Mr. Tuell earned his Bachelor of Social Work degree from James Madison University and his Master of Arts degree in Criminal Justice from George Washington University. He is the proud father of two sons, Austin (age 24) and Zachary (age 18).
