

JJDPA Reauthorization Update

- In spite of serious efforts by members of the Senate Judiciary committee, no compromise has been reached with Sen. Cotton
- The only option is a floor vote which would have to happen in September and the odds are not good
- No legislation has been introduced in the House



Beyond JJDPA Reauthorization: Options Under Consideration

- Further work on other Federal legislation
- Gathering information about what is going on legislatively at the State level
- Work on a legislative proposal to implement recommendations related to placing juveniles on sex offender registry



Federal Legislation

- Examples of currently pending federal legislation
 - Youth Promise Act
 - The Redeem Act
 - Connect Act
 - Juvenile Accountability and Reauthorization of Block Grant and Bullying Prevention and Intervention Act
- Develop Criteria for selection
- Determine SAG support



State Legislative Initiatives

- Develop a survey to send to SAGs designed to gather information about recent state legislative initiatives that improve lives of families, youth and kids
- Compile results and make recommendations to OJJDP



Amendment to Adam Walsh Act

- FACJJ Committee has recommended that juvenile sex offenders no longer be required to register on the sex offender registry
- Implementation of this recommendation requires federal legislation to amend the Adam Walsh Act to remove the requirement that certain juveniles be on the registry

Recommendation #1

Adopted by FACJJ in May 2016

Existing federal law should be amended to explicitly exempt juveniles (all persons who were below the age of 18 at the time of their offense) from all sex offender registration, community notification, and residency restriction laws.

Rationale (overview): Since the passage of federal law requiring the registration of juvenile sex offenders, a wealth of studies have shown no net measurable public safety benefits but have identified multiple unintended negative consequences to youth, victims of sexual abuse and families of both.



Draft Proposed Recommendation #2

Juveniles charged with sex offenses should receive evidence based treatment commensurate with their criminogenic risk, criminogenic needs, and responsivity. Broader efforts should focus on preventing problematic juvenile sexual behavior through early identification and appropriate evidence based interventions.

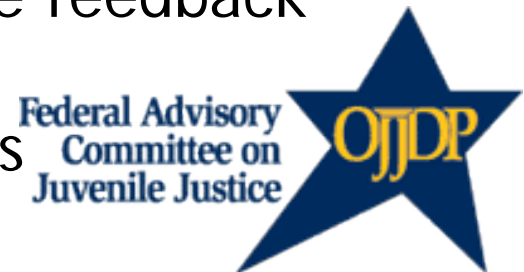
July 26th Subcommittee Meeting Recap

Draft Timeline and Next Steps

- Draft Timeline:
 - July (1st Call): Introduction and initial brainstorming
 - August (2nd Call): Discussion on draft timeline and recommendation themes (assigning specific member ownership to specific themes)
 - October (3rd Call): Review of draft report
 - November (4th Call): Finalizing subcommittee recommendations for December release
- For August call: Members will provide feedback on timeline, topics, and begin thinking of specific recommendations
